RE. TRESPASS NOTICE ISSUED 25 JULY 2025

Matt.

In response to your letter, you should not be surprised by the decision to trespass you from the marae on 25 July 2025. Please do not lecture me on the legalities of this matter. If you truly understand and uphold the principles of tikanga, as you claim, then you should recognise that your actions and behaviour represent a serious breach of those principles.

You were previously a trusted member of our staff in your role as Human Resources Manager, working on our marae for the majority of your employment. That role ended just over three months ago. It is entirely inappropriate and unethical for you to now attempt to use information and relationships gained during your time with us to undermine our kaupapa.

Our marae has the legal right to bar individuals we deem to be a threat to our tikanga, our values, and our mana. We consider you to be such a threat. Accordingly, we have informed the police that you, and anyone representing you, are not permitted access to our marae.

We do accept that you have the legal right to negotiate with workers, however this must take place at another location. There is no negotiation on this point.

Finally, I want to make it absolutely clear that the decision to issue a trespass notice is not about the union process or employment-related matters. The concerns raised about collective bargaining, or personal grievances are separate and should be



addressed in the appropriate forums. My concern is solely with your presence on the marae, and the impact of your actions on the tikanga and mana of our space. These matters are not to be conflated.
