Question: Did the Ministry of Foreign Affairs and Trade supply her with background information on Charlotte Bellis, in particular any consular assistance offered to her, if so, on what date and at what time, and why?

Reply: On 31 January 2022 at 12.55 pm the Ministry of Foreign Affairs and Trade (MFAT) provided my Office with a note regarding MFAT's engagement with Charlotte Bellis and wider consular issues related to Afghanistan raised by media coverage of Bellis's case. The note was provided, in line with established 'no surprises' conventions, because Ms Bellis's situation had received extensive media attention, and it was expected that I would receive requests for comment about MFAT's involvement. Following established practice, the note identified all personal information as 'not for public comment'.

Reply: On the morning of 31 January 2022 my Office discussed the media reporting of the Charlotte Bellis case with MFAT officials and noted that Ms Bellis's situation had received significant media attention, and that I was likely to receive requests for comment about the Ministry's involvement.

Again, I encourage her to take up any offers of assistance", and did the Ministry of Foreign Affairs and Trade provide Mr Hipkins with the information that allowed him to make this statement?

Reply: I have seen those comments. In accordance with established protocols, MFAT did not provide information directly to the Minister for COVID-19 Response. Information received by my Office, being the MFAT briefing note and media lines on consular issues related to Afghanistan, were passed to the Office of the Minister for COVID-19 Response. The media lines provided followed established practice in noting that "for privacy reasons, we do not disclose details regarding individual cases."
